## ELIGIBILITY REQUIREMENTS

1. Must be a graduating senior of Emmett High School or Payette River Technical Academy.
  2. Must have been a 4-H and FFA member for the last three consecutive years.
  3. Must have a cumulative GPA of 3.0 or higher.
  4. Must provide proof of enrollment in a post-secondary institution if reapplying.
  5. If applying for the additional \$250, proof of submission for the FFA State Degree is required.
